## Commercial Water Application Agreement

In consideration of the Bona Vista Water Improvement District supplying culinary water to our property located at \_\_\_\_\_, we hereby agree and covenant as follows:

- a. Each month I/we agree to pay a minimum monthly base rate (based on meter size) and pay for water used. Base Rates and water charges are billed at the current rate set by the District and are subject to change. Bills are generated on the first business day of the month and are due by the last business day of the month.
- b. The District handles the billing and collection of fees for sewer, garbage, storm drain and other miscellaneous services in Plain City, Farr West, Harrisville, Slaterville-Marriott and the unincorporated area of Weber County served by Central Weber Sewer District and by agreement with them, these rates are set by the owning entity and the District merely does the billing and collecting for the same.
- c. A double check valve is required on the street side of the meter for homes built after 1990 per State & Federal regulations. The double check valve causes the plumbing to be a closed system; therefore, it is recommended that all homes have a small expansion tank installed on the plumbing system near the water heater to compensate for the closed system. I/We hereby acknowledge reading this and understand that by installing the check valve it prevents water from going back to the main thus eliminating any cross connection.
- d. Anything laid down in addition to grass around the meter box will require the ring and lid to be changed to an 18" camlock ring and lid at the property owner's expense. The District needs to have access to the meter box when necessary. Should the meter box need to be dug up for any reason, it is the property owner's responsibility to replace any concrete or bricks that might have been placed around it.
- e. The property owner is responsible for all damage occurring at the meter box including, but not limited to the ring and lid, radio, antenna, and register. The District will replace damaged equipment, excluding ring and lid, and will bill the property owner.
